## **TERMS AND CONDITIONS**

1. Sealed bids must be submitted on company letterhead along with CNIC/NTN certificate.
2. Each Bidder shall furnish, as part of its bid, a **Bid Security @ 5%** of the Total Bid Amount in PKR in the form of Pay Order/Demand Draft in the name of “**Karachi Tools, Dies & Moulds Centre**”. Bids without Bid Security shall be rejected.
3. The bidder may bid for any or all of the items as mentioned in the list.
4. KTDMC shall evaluate which bidder quoted the highest price for each item. Accordingly, KTDMC reserve the right to issue the award letter to the successful bidder(s) for those items for which the bidder(s) quoted highest prices.
5. The successful bidder(s) shall deposit 100% of the total bid amount in advance in the form of Pay Order/ Demand Draft within Three (03) days after issuance of award letter, failing which, the bid security shall be forfeited and the company reserve the right to award the contract to the next higher bidder.
6. The successful bidder is bound to pick up only the mentioned quantity and No exceed quantity shall be allowed to pick up to the successful bidder.
7. Delivery to be taken by successful bidder after full payment and the bidder(s) shall remove the scrap items at their own safety, risk and cost from KTDMC premises within 07 working days (Monday to Friday between 10:00 a.m. to 03:30 p.m).
8. The tender in on “**As is Where is**” basis, therefore, sorting of any scrap item by any means is strictly prohibited.
9. Whereas quantities mentioned in the list of scrap items are approximate. Therefore, the actual quantities may vary from the quantities mentioned in the list of scrap items. Therefore, the advance deposited by the successful bidder is refundable to or receivable from the successful bidder to the extent of variation in the quantities.
10. KTDMC is held harmless from any/all claims and losses, acquiring from or resulting to any/all bidders, material, labors, any other person, in connection with performance of this disposal.

11. The bids must be submitted at mentioned company address in sealed envelope and marked as **“Disposal of Miscellaneous Scrap – Tender # 95/KTDMC/2022-23”**.
12. Bids determined to be substantially responsive will be checked for any arithmetic errors and Errors will be corrected as follows:
  - a) If there is a discrepancy between unit rate and the total amount that is obtained by multiplying the unit rate and quantity, the unit rate shall prevail, and the total amount shall be corrected, unless in the opinion of the Procuring Agency there is an obvious misplacement of the decimal point in the unit rate, in which the total amount as quoted shall govern and the unit rate shall be corrected.
  - b) Where there is a discrepancy between the amounts in figures and in words, the amount in words will govern.

The amount stated in the Bid will, be adjusted by the KTDMC in accordance with the above procedure for the correction of errors and, with, the concurrence of the Bidder, shall be considered as binding upon the Bidder. If the Bidder does not accept the corrected amount, its Bid will then be rejected, and the Bid Security may be forfeited.
13. Successful bidder shall be responsible for payment of all taxes, levies and other charges in connection with sales, transfer and pick up of the material, including GST 17% for registered bidders or 17% GST+3% Further GST for Unregistered/Inactive bidders and Advance Tax at rate of 5% filer and 10% for non-filer as per section 236A of the Income Tax Ordinance, 2001.
14. This tender is only an invitation to offer and KTDMC reserves the right to accept or reject all bids/quotations at any time as per the clause 33 of PPRA rules, 2004.
